**BATH AND NORTH EAST SOMERSET COUNCIL (PUBLIC FOOTPATH BA27/47,
THE SHALLOWS, SALTFORD) PUBLIC PATH DIVERSION ORDER 2026**

This order is made by Bath and North East Somerset Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the occupiers of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

BY THIS ORDER:

1. The public right of way over the land situate at The Shallows, Saltford and shown by a bold continuous line on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up from the date that the Authority certifies that work has been carried out to bring the site of the new path described in Article 3 into a fit condition for use by the public.
2. No statutory undertakers' rights are affected by this order.
3. There shall on the date that the Authority certifies that the works to bring the site of the path described in Part 2 of the Schedule into a fit condition for use by the public have been completed to the reasonable satisfaction of the authority, be a public footpath over the land situate at The Shallows, Saltford described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this order.
4. The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

The full width of the section of Public Footpath BA27/47 commencing from a junction with The Shallows at grid reference ST 6871 6692 (point A on the Order Map) and proceeding in a generally north-easterly direction for approximately 42 metres to grid reference ST 6875 6694 (point B on the Order Map) and turning in a generally south-easterly direction for approximately 7 metres to grid reference ST 6875 6694 (point C on the Order Map).

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A public footpath commencing from a junction with The Shallows at grid reference ST 6871 6691 (point D on the Order Map) and proceeding in a generally north-easterly direction for approximately 46 metres to grid reference ST 6875 6694 (point C on the Order Map).

Width: 2.0 metres at grid reference ST 6871 6691 (point D on the Order Map). 2.5 metres between grid references ST 6871 6691 (point D on the Order Map) and ST 6875 6694 (point C on the Order Map).
