

SECTION 14 OF THE ROAD TRAFFIC REGULATION ACT 1984

BATH AND NORTH EAST SOMERSET COUNCIL (PUBLIC FOOTPATHS BA24/9, BA24/10 & BA24/19, GLOUCESTER ROAD, SWAINSWICK) TEMPORARY TRAFFIC REGULATION ORDER 2026

Bath and North East Somerset Council ("the Council") being the highway authority for Public Footpaths BA24/9, BA24/10 & BA24/19 in the County and District of Bath and North East Somerset is satisfied that all traffic in the said public footpaths should be restricted because works are being or are proposed to be executed on or near the said footpaths.

The Council in exercise of its powers under section 14 of the Road Traffic Regulation Act 1984 and of all other enabling powers hereby makes the following order:

1. No person shall proceed in that length of Public Footpath BA24/9 commencing from a junction with Gloucester Road at grid reference ST 7588 6863 (point A on the Order Plan) and proceeding in a generally northerly direction for approximately 331 metres to a junction with Public Footpath BA24/10 at grid reference ST 7588 6896 (point B on the Order Plan); nor in that length of Public Footpath BA24/10 commencing from a junction with Gloucester Road at grid reference ST 7585 6866 (point C on the Order Plan) and proceeding in a generally northerly direction for approximately 432 metres to a junction with Public Footpath BA24/9 at grid reference ST 7588 6896 (point B on the Order Plan); nor in that length of Public Footpath BA24/19 commencing from a junction with Gloucester Road at grid reference ST 7595 6856 (point D on the Order Plan) and proceeding in a generally northeasterly direction for approximately 85 metres to a junction with Public Footpaths BA2/49A and BA2/51 at grid reference ST 7600 6862 (point E on the Order Plan).
2. Nothing in Article 1 of this order shall apply to any contractor necessarily proceeding to or from the said works.
3. This order shall come into operation on 19 January 2026 and will be operative until 20 March 2026. The Order may be cited as the Bath and North East Somerset Council (Public Footpaths BA24/9, BA24/10 & BA24/19, Temple Street, Keynsham) Temporary Traffic Regulation Order 2026.
