**BATH AND NORTH EAST SOMERSET COUNCIL
(PUBLIC FOOTPATHS BA7/14, BA7/15 & BA25/41, ANCHOR LANE, COMBE HAY)
TEMPORARY TRAFFIC REGULATION ORDER 2026**

Bath and North East Somerset Council ("the Council") being the highway authority for Public Footpaths BA7/14, BA7/15 & BA25/41 in the County and District of Bath and North East Somerset is satisfied that all traffic in the said public footpaths should be restricted because works are being or are proposed to be executed on or near the said footpaths: namely the renovation of a water main by Bristol Water.

The Council in exercise of its powers under section 14 of the Road Traffic Regulation Act 1984 and of all other enabling powers hereby makes the following order:

1. No person shall proceed in that length of Public Footpath BA24/9 commencing from a junction with Anchor Lane at grid reference ST 7320 5987 (point A on the Order Plan) and proceeding in a generally southerly direction for approximately 220 metres to a junction with Public Footpath BA25/41 at grid reference ST 7322 5966 (point B on the Order Plan); that length of Public Footpath BA25/41 commencing from a junction with Public Footpath BA7/14 at grid reference ST 7322 5966 (point B on the Order Plan) and proceeding in a generally southerly direction for approximately 560 metres to a junction with Bath Hill at grid reference ST 7329 5912 (point C on the Order Plan); and that length of Public Footpath BA7/15 commencing from a junction with Public Footpath BA7/14 at grid reference ST 7319 5984 (point D on the Order Plan) and proceeding in a generally west-southwesterly direction for approximately 439 metres to a junction with Mill Hill at grid reference ST 7283 5962 (point E on the Order Plan).
2. Nothing in Article 1 of this order shall apply to any contractor necessarily proceeding to or from the said works.
3. This order shall come into operation on 4 May 2026 and will be operative until 23 October 2026. The Order may be cited as the Bath and North East Somerset Council (Public Footpaths BA7/14, BA7/15 & BA25/41, Anchor Lane, Combe Hay) Temporary Traffic Regulation Order 2026.

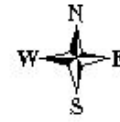
Temporarily closed footpath
