

**WILDLIFE AND COUNTRYSIDE ACT 1981**

CLUTTON RURAL DISTRICT DEFINITIVE MAP AND STATEMENT**

**BATH AND NORTH EAST SOMERSET COUNCIL  
(PUBLIC BRIDLEWAYS CL6/45 AND CL11/41, GREYFIELD,  
CLUTTON AND HIGH LITTLETON) MODIFICATION ORDER 2025**

This Order is made by Bath and North East Somerset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Somerset County Council, Clutton Rural District Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(b) namely, the expiration, in relation to any way in the area to which the map relates, of any period such that the enjoyment by the public of the way during that period raises a presumption that the way has been dedicated as a public path; and an event specified in section 53(3)(c)(ii) namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description; and an event specified in section 53(3)(c)(iii) namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that any other particulars contained in the map and statement require modification.

The authority has consulted with every local authority whose area includes the land to which the Order relates. The Bath and North East Somerset Council hereby order that:

1. For the purposes of this Order the relevant date is 23<sup>rd</sup> January 2025.
2. The Somerset County Council, Clutton Rural District Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the Bath and North East Somerset Council (Public Bridleways CL6/45 and CL11/41, Greyfield, Clutton and High Littleton) Modification Order 2025

## **SCHEDULE**

### **PART I**

#### **Modification of Definitive Map**

##### **Description of path or way to be added**

The public bridleway commences from a junction with Maynard Terrace in Clutton at grid reference ST 6321 5904 (point A on the Order Map) and proceeds in a generally east-south-easterly direction for approximately 14 metres to a gap adjacent to a locked field gate at grid reference ST 6322 5903 (point B on the Order Map). The route continues in a generally east-south-easterly direction for approximately 380 metres to a junction with public footpath CL6/4 at grid reference ST 6354 5883 (point C on the Order Map). The route continues in a generally east-south-easterly direction for approximately 245 metres to a gap adjacent to a locked vehicle barrier at grid reference ST 6376 5872 (point D on the Order Map). The route continues in a generally east-south-easterly direction for approximately 245 metres to a junction with public footpath CL6/40 at grid reference ST 6397 5859 (point E on the Order Map).

##### **Description of path or way to be upgraded**

The public footpath to be upgraded to public bridleway commences from grid reference ST 6397 5859 (point E on the Order Map) and proceeds in a generally north-easterly direction for approximately 83 metres to a junction with Greyfield Road in High Littleton at grid reference ST 6404 5864 (point G on the Order Map).

The public bridleway commences from a junction with Maynard Terrace in Clutton at grid reference ST 6321 5904 and proceeds in a generally east-south-easterly direction for approximately 14 metres to a gap adjacent to a locked field gate at grid reference ST 6322 5903. The route continues in a generally east-south-easterly direction for approximately 380 metres to a junction with public footpath CL6/4 at grid reference ST 6354 5883. The route continues in a generally east-south-easterly direction for approximately 245 metres to a gap adjacent to a locked vehicle barrier at grid reference ST 6376 5872. The route continues in a generally east-south-easterly direction for approximately 245 metres to a junction with public bridleway CL11/41 and public footpath CL6/40 at grid reference ST 6397 5859.

A new statement for CL11/41 shall be recorded as follows:

**General Description:**

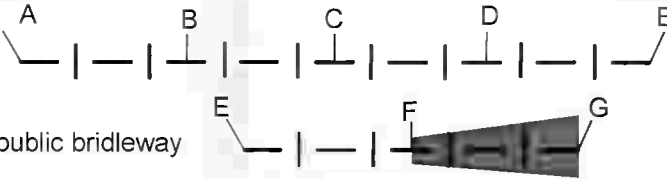
