BATH AND NORTH EAST SOMERSET COUNCIL (PUBLIC FOOTPATH BA27/88, SOMERDALE, KEYNSHAM) DEFINITIVE MAP MODIFICATION ORDER 2024

The above Order made on 30th January 2025, if confirmed as made, will modify the definitive map and statement for the area by adding to them the footpath from a junction with public footpath BA27/5 at grid reference ST 6536 6905 and proceeding in a generally north-westerly direction adjacent to the Great Western Railway for approximately 157 metres to grid reference ST 6523 6914 and turning in a generally north-easterly direction under the railway line for approximately 45 metres to a stile at grid reference ST 6526 6917 and continuing for approximately 12 metres to a junction with public footpath BA27/87 at grid reference ST 6527 6918.

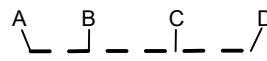
Any representation or objection relating to the order must be sent in writing to the Public Rights of Way Team, Bath and North East Somerset Council, Lewis House, Manvers Street, Bath, BA1 1JG not later than **1st August 2025** and applicants are requested to state the grounds on which it is made. Please note that all representations received will be considered in public by the Council and that the substance of any representation together with the name and address of the person making it will become available for public inspection.

If no representations or objections are duly made to the order, or to any part of it, or if any so made are withdrawn, the Bath and North East Somerset Council, instead of submitting the order to the Secretary of State (or part of it if the authority has by notice to the Secretary of State so elected under paragraph 5 of Schedule 15 to the Wildlife and Countryside Act 1981) may itself confirm the order (or that part of the order). If the order is submitted to the Secretary of State for Environment, Food & Rural Affairs, in whole or in part, any representations or objections which have not been withdrawn will be sent with it.
