## PUBLIC FOOTPATHS IN PERRYMEAD, BATH.

I understand that the path running along the line of the old railway up to the northern end of the Combe Down tunnel is in your ownership and that it has been designated as a public footpath, despite the fact that it is effectively a cul-de-sac. Certainly it appears to be used regularly by members of the public for recreational walking.

Unfortunately there is currently no indication to walkers reaching the (blocked up) entrance to the tunnel that the footpath terminates at that point, and that they should turn back.

In the absence of any signs to this effect some walkers do not turn back, but continue in the same general direction, up the hillside over the tunnel and into the woods. From there they enter and cross my field, to emerge via my field gate on Perrymead itself. I enclose a copy of the relevant map upon which I have marked in green the general line taken by walkers across my land.

I would like to point out that the public has no right to use this route. I would therefore ask you to take steps to ensure that this is made clear to walkers reaching the end of the public path, perhaps by an explanatory notice advising them to return the way they came.

To assist walkers travelling the other way, that is to say from Perrymead to Lyncombe, might I also suggest that the footpath leading from the north-west corner of Perrymead down to Lyncombe (via the footbridge over the old railway line) be clearly waymarked at Perrymead. There is no sign there at present and this may be part of the reason why people tend to strike across my land, rather than use this public footpath (No 76?) as they should.
