This Order is made by Bath and North East Somerset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to that authority that the City of Bath Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i), namely, that rights of way which are not shown in the map and statement subsist or are reasonably alleged to subsist over land in the area to which the map relates, being rights of way such that the land over which the rights subsist are public paths.

The authority has consulted with every local authority whose area includes the land to which the order relates. The Bath and North East Somerset Council hereby order that:

1. For the purposes of this order the relevant date is 11<sup>th</sup> July 2017.
2. The City of Bath Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the Bath and North East Somerset Council City of Bath Definitive Map and Statement Modification Order (No. 13 – Twerton) 2017.



The footpath continues for a distance of approximately 15 metres to steps at point G at Grid Reference ST 7194 6396. The footpath continues up the steps for a distance of approximately 2 metres to point H at Grid Reference ST 7194 6396 where the steps end. The footpath continues for a distance of approximately 2 metres to where it finishes at point I at Grid Reference ST 7194 6396 on Windrush Close and shown by a broken black line with short intervals marked A-B-C-D-E-F-G-H-I on the map numbered Part 1 attached to this Order, the number of this footpath to be known as BC13/2.

##### **BC14/3**

A footpath in Bath and North East Somerset running from point A on the map at Part 2 at Grid Reference ST 7171 6490 on public footpath BC14/6 and continuing for a distance of approximately 147 metres in a generally east-north-easterly direction to staggered barriers at point B at Grid Reference ST 7186 6491. The footpath continues for a distance of approximately 31 metres to where it finishes at point C at Grid Reference ST 7189 6491 on Redland Park and shown by a broken black line with short intervals marked A-B-C on the map numbered Part 2 attached to this Order, the number of this footpath to be known as BC14/3.

##### **BC14/4**

A footpath in Bath and North East Somerset running from point A on the map at Part 3 at Grid Reference ST 7177 6488 on Redland Park and continuing for a distance of approximately 93 metres in a generally easterly direction to point B at Grid Reference ST 7186 6489 where the direction changes to generally southerly. The footpath continues for a distance of approximately 12 metres to where it finishes at point C at Grid Reference ST 7186 6488 on Redland Park and shown by a broken black line with short intervals marked A-B-C on the map numbered Part 3 attached to this Order, the number of this footpath to be known as BC14/4.

##### **BC14/6**

A footpath in Bath and North East Somerset running from point A on the map at Part 4 at Grid Reference ST 7172 6487 on public footpath BC14/10 and continuing for a distance of

approximately 24 metres in a generally northerly direction to a junction with public footpath BC14/7 at point B at Grid Reference ST 7171 6489. The footpath continues for a distance of approximately 36 metres to point C at Grid Reference ST 7171 6493 where the direction changes to generally easterly. The footpath continues for a distance of approximately 39 metres to staggered barriers at point D at Grid Reference ST 7175 6493. The footpath continues for a distance of approximately 125 metres to staggered barriers at point E at Grid Reference ST 7188 6494. The footpath continues for a distance of approximately 12 metres to a junction with public footpath BC14/1 at point F at Grid Reference ST 7189 6494. The footpath continues for a distance of approximately 16 metres to where it finishes at point G at Grid Reference ST 7190 6494 on Redland Park and shown by a broken black line with short intervals marked A-B-C-D-E-F-G on the map numbered Part 4 attached to this Order, the number of this footpath to be known as BC14/6.

#### **BC14/8**

A footpath in Bath and North East Somerset running from Point A on the map at Part 5 at Grid Reference ST 7197 6492 on Redland Park and continuing for a distance of approximately 9 metres in a generally south-easterly direction to point B at Grid Reference ST 7197 6491 where the direction changes to generally east-north-easterly. The footpath continues for a distance of approximately 29 metres to point C at Grid Reference ST 7200 6492 where the direction changes to generally north-easterly. The footpath continues for a distance of approximately 58 metres to point D at Grid Reference ST 7205 6495 where the direction changes to generally easterly. The footpath continues for a distance of approximately 28 metres to point E at Grid Reference ST 7208 6495 at a junction with public footpath BC24/7 where the direction changes to generally southerly. The footpath continues for a distance of approximately 6 metres to point F at Grid Reference ST 7208 6495 at a staggered barrier and continues for a further distance of approximately 12 metres to where it finishes at point G at Grid Reference ST 7208 6494 on Woodhouse Road and shown by a broken black line with short intervals marked A-B-C-D-E-F-G on the map numbered Part 5 attached to this Order, the number of this footpath to be known as BC14/8.

#### **BC14/9**

A footpath in Bath and North East Somerset running from point A on the map at Part 6 at Grid Reference ST 7196 6486 on Redland Park and continuing for a distance of approximately 5 metres in a generally south-south-easterly direction to point B at Grid Reference ST 7196 6486 where the direction changes to generally north-easterly. The footpath continues for a distance of approximately 21 metres to point C at Grid Reference ST 7198 6486 where it changes direction to generally north-north-easterly. The footpath continues for a distance of approximately 4 metres to point D at Grid Reference ST 7198 6487 where it changes direction to generally north-easterly. The footpath continues for a distance of approximately 2 metres to point E at Grid Reference ST 7199 6487 at a junction with public footpath BC14/2. The footpath continues for a distance of approximately 5 metres to point F at Grid Reference ST 7199 6487 where it changes direction to generally easterly. The footpath continues for a distance of approximately 39 metres to point G at Grid Reference ST 7203 6487 where it changes direction to generally north-easterly. The footpath continues for a distance of approximately 25 metres to point H at Grid Reference ST 7205 6489 where it changes direction to generally easterly. The footpath continues for a distance of approximately 12 metres to point I at Grid Reference ST 7206 6489 where the direction changes to generally northerly. The footpath continues for a distance of approximately 17 metres to steps at point J at Grid

Reference ST 7206 6490. The footpath continues up the steps for a distance of approximately 1 metre to point K at Grid Reference ST 7206 6491. The footpath continues for a distance of approximately 5 metres to where it finishes at point L at Grid Reference ST 7206 6491 on Woodhouse Road and shown by a broken black line with short intervals marked A-B-C-D-E-F-G-H-I-J-K-L on the map numbered Part 6 attached to this Order, the number of this footpath to be known as BC14/9.

#### **BC14/10**

A footpath in Bath and North East Somerset running from point A on the map at Part 7 at Grid Reference ST 7167 6472 on public footpath BC14/11 and continuing for a distance of approximately 14 metres in a generally north-north-westerly direction to point B at Grid Reference ST 7167 6473 where the direction changes to generally north-north-easterly. The footpath continues for a distance of approximately 72 metres to point C at Grid Reference ST 7171 6479 at a junction with public footpath BC14/5. The footpath continues for a distance of approximately 86 metres to point D at Grid Reference ST 7172 6487 where it finishes on public footpath BC14/6 and shown by a broken black line with short intervals marked A-B-C-D on the map numbered Part 7 attached to this Order, the number of this footpath to be known as BC14/10.

#### **BC14/11**

A footpath in Bath and North East Somerset running from point A on the map at Part 8 at Grid Reference ST 7146 6469 at a footbridge on public footpath BA17/8 and continuing through point B at Grid Reference ST 7147 6469 for a distance of approximately 190 metres in a generally east-north-easterly direction to a kissing gate at point C at Grid Reference ST 7165 6471. The footpath continues for a distance of approximately 24 metres to point D at Grid Reference ST 7167 6472 at a junction with public footpath BC14/10, where the direction changes to generally south-easterly. The footpath continues for a distance of approximately 90 metres to where it finishes at point E at Grid Reference ST 7175 6466 on Newton Road and shown by a broken black line with short intervals marked A-B-C-D-E on the map numbered Part 8 attached to this Order, the number of this footpath to be known as BC14/11.

#### **BC14/12**

A footpath in Bath and North East Somerset running from point A on the map at Part 9 at Grid Reference ST 7193 6475 on Newton Road and continuing for a distance of approximately 27 metres in a generally south-south-easterly direction to where it finishes at point B at Grid Reference ST 7194 6472 on the access road for Cameley Green and Cleeve Green and shown by a broken black line with short intervals marked A-B on the map numbered Part 9 attached to this Order, the number of this footpath to be known as BC14/12.

#### **BC14/13**

A footpath in Bath and North East Somerset running from point A on the map at Part 10 at Grid Reference ST 7194 6471 on the access road for Cameley Green and Cleeve Green and continuing for a distance of approximately 85 metres in a generally south-south-easterly direction to where it finishes at point B at Grid Reference ST 7197 6463 on the access road for Cameley Green and Cleeve Green and shown by a broken black line with short intervals marked A-B on the map numbered Part 10 attached to this Order, the number of this footpath to be known as BC14/13.

**BC14/14**

A footpath in Bath and North East Somerset running from point A on the map at Part 11 at Grid Reference ST 7178 6468 on Newton Road and continuing for a distance of approximately 32 metres in a generally south-easterly direction to where it finishes at point B at Grid Reference ST 7180 6465 on the access road for Cameley Green and Cleeve Green and shown by a broken black line with short intervals marked A-B on the map numbered Part 11 attached to this Order, the number of this footpath to be known as BC14/14.

**BC14/15**

A footpath in Bath and North East Somerset running from point A on the map at Part 12 at Grid Reference ST 7171 6456 on Newton Road and continuing for a distance of approximately 33 metres in a generally south-easterly direction to where it finishes at point B at Grid Reference ST 7174 6455 on the access road for Cameley Green and Cleeve Green and shown by a broken black line with short intervals marked A-B on the map numbered Part 12 attached to this Order, the number of this footpath to be known as BC14/15.

**BC14/16**

**BC14/18**
