**WILDLIFE AND COUNTRYSIDE ACT 1981**

**CITY OF BATH DEFINITIVE MAP AND STATEMENT**

**Bath and North East Somerset Council (City of Bath Definitive Map and Statement  
Modification Order) (No. 7 – Abbey) 2008**

This Order is made by Bath and North East Somerset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to that authority that the City of Bath Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i), namely, that rights of way which are not shown on the map and statement subsist or are reasonably alleged to subsist over land in the area to which the maps relate, being rights of way to which this Part applies.

The authority has consulted with every local authority whose area includes the land to which the order relates. The Bath and North East Somerset Council hereby order that:

1. For the purposes of this order the relevant date is 8<sup>th</sup> July 2008.
2. The City of Bath Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the maps attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the Bath and North East Somerset Council (City of Bath Definitive Map and Statement Modification Order) (No. 7 – Abbey) 2008.

AQ347

A footpath in Bath and North East Somerset running from a bollard at point A at Grid Reference ST 7490 6527 on Alfred Street and continuing in a south-south-easterly direction for a distance of approximately 40m to a bollard at point B at Grid Reference ST 7491 6523. The footpath continues for a distance of approximately 54m to a bollard where it finishes on George Street at point C at Grid Reference ST 7493 6518 and shown by a broken black line with short intervals marked A–B–C on the map numbered AQ347 annexed to this order, the number of this footpath to be known as BC45/20.

AQ348

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7484 6514 on George Street and continuing in a north-north-westerly direction for a distance of approximately 69m to point B at Grid Reference ST 7482 6521 where the direction changes to east-north-easterly. The footpath continues for a distance of approximately 93m to where it finishes on Bartlett Street at point C at Grid Reference ST 7491 6523 and shown by a broken black line with short intervals marked A–B–C on the map numbered AQ348 annexed to this order, the number of this footpath to be known as BC45/21.

AQ359

A footpath in Bath and North East Somerset running from steps at Grid Reference ST 7509 6559 at point A on The Paragon and continuing in a south-easterly direction for a distance of approximately 8m to a barrier at point B at Grid Reference ST 75105 65592. The footpath continues for a distance of approximately 4m to a barrier where it finishes on London Street at point C at Grid Reference ST 7510 6559 and shown by a broken black line with short intervals marked A–B–C on the map numbered AQ359 annexed to this order, the number of this footpath to be known as BC55/4.

A footpath in Bath and North East Somerset running from bollards at point A at Grid Reference ST 7511 6557 on London Street and continuing in a south-easterly direction for a

The footpath continues down the steps for a distance of approximately 18m to where it finishes on The Paragon at point C at Grid Reference ST 7503 6545 and shown by a broken black line with short intervals marked A-B-C on the map numbered AQ569 annexed to this order, the number of this footpath to be known as BC55/6.

A footpath in Bath and North East Somerset running from steps at point A at Grid Reference ST 7521 6495 on Argyle Street and continuing down the steps in an overall southerly direction for a distance of approximately 8m to point B at Grid Reference ST 75213 64952. The footpath continues in a south-south-easterly direction for a distance of approximately 12m to steps at point C at Grid Reference ST 75217 64942 and continues down the steps for a distance of approximately 3m to point D at Grid Reference ST 75219 64940 where the direction changes to north-easterly. The footpath continues down the steps for a distance of approximately 2m to point E at Grid Reference ST 75221 64942. The footpath continues for a distance of approximately 9m to point F at Grid Reference ST 7522 6494 where the direction changes to south-easterly. The footpath continues for a distance of approximately 30m to where it finishes on Spring Gardens Road at point G at Grid Reference ST 7525 6493 and shown by a broken black line with short intervals marked A-B-C-D-E-F-G on the map numbered CQ38 annexed to this order, the number of this footpath to be known as BC54/8.

#### CQ39
















