CITY OF BATH DEFINITIVE MAP AND STATEMENT

Bath and North East Somerset Council (City of Bath Definitive Map and Statement Modification Order) (No.3 - Lambridge and Walcot) 2006

This Order is made by Bath and North East Somerset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to that authority that the City of Bath Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i), namely that a right of way which is not shown on the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way to which this Part applies.


The authority has consulted with every local authority whose area includes the land to which the order relates. The Bath and North East Somerset Council hereby order that:

1. For the purposes of this order the relevant date is 1st June 2006.
2. The City of Bath Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the Bath and North East Somerset Council (City of Bath Definitive Map and Statement Modification Order) (No.3 - Lambridge and Walcot) 2006.

AQ317a

A footpath in Bath and North East Somerset running from point A on Whitewells Road at Grid Reference ST 7539 6682 in a north easterly direction for a distance of approximately 82m to point B where it ends on Whitewells Road at Grid Reference ST 7544 6689 and shown by a broken black line with short intervals marked A-B on the map numbered AQ317a annexed to this order, the number of this footpath to be known as BC56/9.

AQ317d

A footpath in Bath and North East Somerset running from point A on Whitewells Road at Grid Reference ST 7538 6686 in a south easterly direction for a distance of approximately 40m to point B where it ends at the junction of AQ317a and AQ317e at Grid Reference ST 7541 6684 and shown by a broken black line with short intervals marked A-B on the map numbered AQ317d annexed to this order, the number of this footpath to be known as BC56/8.

AQ317e

A footpath in Bath and North East Somerset running from point A at the junction of AQ317a and AQ317d at Grid Reference ST 7541 6684 in a south easterly direction for a distance of approximately 23m to point B where it ends on Whitewells Road at Grid Reference ST 7543 6682 and shown by a broken black line with short intervals marked A-B on the map numbered AQ317e annexed to this order, the number of this footpath to be known as BC56/10.

AQ318

A footpath in Bath and North East Somerset running from point A on AQ4a at Grid Reference ST 7561 6687 in a south easterly direction for a distance of approximately 53m to steps at point B at Grid Reference ST 7566 6685 and continues for a distance of approximately 17m down the steps to point C at Grid Reference ST 7567 6683. The footpath continues for a distance of approximately 67m to bollards at point D at Grid Reference ST 7573 6680. The footpath continues for a distance of approximately 17m to point E where it ends on Spring Lane at Grid Reference ST 7574 6679 and shown by a broken black line with short intervals marked A-B-C-D-E on the map numbered AQ318 annexed to this order, the number of this footpath to be known as BC56/17.

AQ320a

A footpath in Bath and North East Somerset running from steps at point A on Batstone Close at Grid Reference ST 7558 6681 and continuing in a north easterly direction for a distance of approximately 15m to point B at Grid Reference ST 7559 6681 where the steps end. The direction changes to north-north easterly for a distance of approximately 5m to steps at point C at Grid Reference ST 75595

66820. The footpath continues down the steps for a distance of approximately 8m to point D at Grid Reference ST 75599 66827. It then continues for a distance of approximately 10m to point E at Grid Reference ST 7560 6683 where the direction changes to south easterly and continues for a distance of approximately 7m to point F at Grid Reference ST 75604 66834 where it ends on Coxley Drive at Grid Reference ST 75611 66833 and shown by a broken black line with short intervals marked A-B-C-D-E-F on the map numbered AQ320a annexed to this order, the number of this footpath to be known as BC56/16.

AQ321a

A footpath in Bath and North East Somerset running from point A on Leigh Close at Grid Reference ST 7509 6660 in a westerly direction for a distance of approximately 16m to point B at Grid Reference ST 7507 6601 where the direction changes to south westerly. The footpath continues for a distance of approximately 12m to point C at Grid Reference ST 7507 6659 where the direction changes to south easterly and continues for a distance of approximately 27m to point D where it ends on AQ321b at Grid Reference ST 7508 6656 and shown by a broken black line with short intervals marked A-B-C-D on the map numbered AQ321a annexed to this order, the number of this footpath to be known as BC56/4.

AQ321b

A footpath in Bath and North East Somerset running from point A on Solsbury Way at Grid Reference ST 7507 6655, down two sets of steps for a distance of approximately 35m with an overall direction of north easterly, to point B at Grid Reference ST 7508 6656. The footpath continues for a distance of approximately 30m in a south easterly direction to point C at Grid Reference ST 7511 6655 where the direction changes to north easterly. The footpath continues for a distance of approximately 20m, down steps at point D at Grid Reference ST 7511 6655, to point E at Grid Reference ST 7512 6655 where the direction changes to north westerly. The footpath continues for a distance of approximately 4m, down steps to point F at Grid Reference ST 7512 6656 where the direction changes to north easterly. After a distance of approximately 4m, the footpath ends at point G on Leigh Close at Grid Reference ST 7512 6656 and shown by a broken black line with short intervals marked A-B-C-D-E-F-G on the map numbered AQ321b annexed to this order, the number of this footpath to be known as BC56/5.

AQ4a

A footpath in Bath and North East Somerset running from point A on Batstone Close at Grid Reference ST 7557 6681 in a generally north-north easterly direction for a distance of approximately 85m to steps at point B at Grid Reference ST 7561 6687. The footpath continues down the steps for a distance of approximately 2m and then for a distance of approximately 6m to steps at point C at Grid Reference ST 7561 6688. The footpath continues for a distance of approximately 75m to point D where it ends on footpath BA5/2 at Grid Reference ST 7562 6695 and shown by a broken black line with short intervals marked A-B-C-D on the map numbered AQ4a annexed to this order, the number of this footpath to be known as BC56/15.

AQ4b

A footpath in Bath and North East Somerset running from point A on BQ35 at Grid Reference ST 7555 6659 in a north-north easterly direction for a distance of approximately 66m to steps at point B at Grid Reference ST 75571 66661 and continues for a distance of approximately 3m to where it ends at point C on Malvern Buildings at Grid Reference ST 75570 66663 and shown by a broken black line with short intervals marked A-B-C on the map numbered AQ4b annexed to this order, the number of this footpath to be known as BC56/13(Part).

BQ33

A footpath in Bath and North East Somerset running from point A on Bay Tree Road at Grid Reference ST 7554 6675 in a north-north easterly direction for a distance of approximately 48m to steps at point B where it ends on Batstone Close at Grid Reference ST 7556 6680 and shown by a

broken black line with short intervals marked A–B on the map numbered BQ33 annexed to this order, the number of this footpath to be known as BC56/12.

BQ34

A footpath in Bath and North East Somerset running from point A on AQ4b at Grid Reference ST 7557 6666 in an east-north easterly direction for a distance of approximately 30m to steps at point B at Grid Reference ST 7560 6666. The footpath continues for a distance of approximately 3m to point C where it ends on Bay Tree Road at Grid Reference ST 7560 6667 and shown by a broken black line with short intervals marked A–B–C on the map numbered BQ34 annexed to this order, the number of this footpath to be known as BC56/14.

BQ35

A footpath in Bath and North East Somerset running from point A on Midsummer Buildings at Grid Reference ST 7556 6654 in a northerly direction for a distance of approximately 51m to point B where it ends on AQ4b at Grid Reference ST 7555 6659 and shown by a broken black line with short intervals marked A–B on the map numbered BQ35 annexed to this order, the number of this footpath to be known as BC56/13(Part).


