- public footpath (FP) BA17/1 running from grid reference ST 7033 6568 (point E on Part 1 of the Order Map) and proceeding in a generally north northeasterly direction for approx 10m to a junction with FP BA17/3 at ST 7033 6569 (point C) to a new line running from grid reference ST 7033 6568 (point E) and proceeding in a generally north northwesterly direction for approx 235m to a junction with FP BA17/3 at ST 7013 6579 (point F);
- FP BA17/3 running from ST 7007 6580 (point A on Part 1 of the Order Map) and proceeding in a generally easterly direction for approx 115 m to ST 7017 6582 (point B) and turning in a generally southeasterly direction for approx 232 m to ST 7033 6569 (point C) and turning in a generally north northeasterly direction for approx 243 m to ST 7040 6590 (point D) to a new line running from ST 7007 6580 (point A) and proceeding in a generally easterly direction for approx 69 m to a junction with FP BA17/1 at ST 7013 6579 (point F) and turning in a generally east northeasterly direction for approx 313 m to ST 7040 6590 (point D); and
- FP BA17/3 running from ST 7142 6602 (point G on Part 2 of the Order Map) and proceeding in a generally east southeasterly direction for approx 245 m to ST 7163 6591 (point H) and turning in a generally southerly direction for approx 118 m to ST 7164 6579 (point J) to a new line running from reference ST 7142 6602 (point G) and proceeding in a generally east southeasterly direction for approx 217 m to reference ST 7160 6592 (point K) and turning in a generally south southeasterly direction for approx 133 m to ST 7164 6579 (point J),
