On 27<sup>th</sup> September 2021 the Secretary of State for the Environment, Food and Rural Affairs confirmed the above order made under section 118 of the Highways Act 1980.

The effect of the order as confirmed is to extinguish the sections of public footpaths (FPs):

<u>FP BA5/35</u> running from grid reference ST 7267 6819 (point F on the Order Map) and proceeding in a generally N direction for approx 385m to ST 7261 6856 (point G on the Order Map);

<u>FP BA5/37</u> running from ST 7191 6891 (point H on the Order Map) and proceeding in a generally WNW direction for approx 139m to a junction with FP BA5/43 and FP BA5/45 at ST 7178 6897 (point A on the Order Map);

<u>FP BA5/43</u> running from ST 7182 6898 (point J on the Order Map) and proceeding in a generally W direction for approx 41m to a junction with FP BA5/45 and FP BA5/37 at ST 7178 6897 (point A on the Order Map);

<u>FP BA5/45</u> running from a junction with FP BA5/43 and FP BA5/37 at ST 7178 6897 (point A on the Order Map) and proceeding in a generally WSW direction for approx 137m to ST 7166 6891 (point B on the Order Map) and turning in a generally SSW direction for approx 592m to a junction with FP BA5/46 and FP BA5/47 at ST 7139 6839 (point C on the Order Map);

<u>FP BA5/46</u> running from a junction with FP BA5/36 and FP BA5/37 at ST 7210 6883 (point D on the Order Map) and proceeding in a generally WSW direction for approx 321m to ST 7181 6868 (point E on the Order Map)

as shown on the order map.

The order came into force on 14<sup>th</sup> November 2021 but if any person aggrieved by the order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within six weeks from the date of this notice, make an application to the High Court.
