## NOTICE OF CONFIRMATION OF AN ORDER HIGHWAYS ACT 1980 BATH AND NORTH EAST SOMERSET COUNCIL

## BATH AND NORTH EAST SOMERSET COUNCIL (PUBLIC FOOTPATHS BA27/19 AND BA27/20, RIVER TERRACE AND MEMORIAL PARK, KEYNSHAM) PUBLIC PATH DIVERSION ORDER 2019

On 18<sup>th</sup> July 2019, Bath and North East Somerset Council confirmed the above order made under section 119 of the Highways Act 1980.

The effect of the order as confirmed is to divert the sections of the public footpaths:

- running from a junction with Public Footpath (FP) BA27/20 at grid reference ST 6554 6840 (point A on the order map) and proceeding in a generally SE direction for approx 78m to a junction with FP BA27/19 at ST 6559 6834 (point B) to a new line running from a junction with FP BA27/74 at ST 6553 6842 (point H) and proceeding in a generally ENE direction for approx 4m to ST 6554 6842 (point J) and turning in a generally S direction for approx 35m to a junction with a new FP at ST 6555 6839 (point K) and turning in a generally WSW direction for approx 1m to a junction with unnumbered FP at River Terrace at ST 6554 6839 (point L);
- 2. running from a junction with FP BA27/19 at ST 6554 6840 (point A) and proceeding in a generally S direction for approx 47m to a junction with unnumbered FP at River Terrace at ST 6554 6835 (point C) to a new line running from a junction with a new FP at ST 6555 6839 (point K) and proceeding in a generally NE direction for approx 9m to ST 6555 6839 (point M) turning in a generally E direction via steps for approx 9m to ST 6556 6839 (point N) and turning in a generally S direction via steps for approx 16m to ST 6557 6838 (point P) and turning in a generally NE direction for approx 42m to a junction with FP BA27/19 at ST 6560 6839 (point Q);
- 3. running from a junction with unnumbered FP at River Terrace at ST 6555 6833 (point D) and proceeding in a generally SSE direction for approx 175m to a junction with FP BA27/19 at ST 6559 6816 (point E) to a new line running from a junction with unnumbered public footpath at River Terrace at ST 6556 6834 (point R) and proceeding via steps in a generally SSE direction for approx 16m to ST 6556 6832 (point S) and turning in a generally N direction for approx 13m to ST 6556 6834 (point T) and turning in a generally E direction for approx 14m to ST 6558 6834 (point U) and turning in a generally S direction for approx 191m to a junction with FP BA27/19 at ST 6559 6816 (point V);
- running from a point at ST 6563 6823 (point F) and proceeding in a generally SSE direction for approx 58m to a junction with FP BA27/19 at ST 6564 6817 (point G) to a new line running from ST 6563 6823 (point F) and proceeding in a generally S direction for approx 58m to a junction with FP BA27/19 at ST 6563 6817 (point W);

as shown on the order map.

The order came into force on 25<sup>th</sup> July 2019 but if any person aggrieved by the order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within six weeks from the date of this notice, make an application to the High Court.
