BATH AND NORTH EAST SOMERSET COUNCIL (PUBLIC FOOTPATHS BA8/26 & BA15/24, WICK FARM, COMPTON DANDO) TEMPORARY TRAFFIC REGULATION ORDER 2025

Bath and North East Somerset Council ("the Council") being the highway authority for Public Footpaths BA8/26 and BA15/24 in the County and District of Bath and North East Somerset is satisfied that pedestrian traffic in the said public footpaths should be restricted because of the likelihood of danger to the public; namely the danger caused by a damaged footbridge which requires replacement before the footpaths can once again be used safely.

The Council in exercise of its powers under section 14 of the Road Traffic Regulation Act 1984 and of all other enabling powers hereby makes the following order:

- 1. No person shall proceed in that length of Public Footpath BA8/26 commencing from a junction with Public Footpaths BA8/77 and BA8/81 at grid reference ST 6494 6285 (Point A on the Order Plan) and proceeding in a generally easterly direction for approximately 770 metres to a junction with Public Footpath BA15/24 at grid reference ST 6560 6276 (Point B on the Order Plan); and the section of Public Footpath BA15/24 commencing from a junction with Public Footpath BA8/26 at grid reference ST 6560 6276 (Point B on the Order Plan) and continuing in a generally east-southeasterly direction for approximately 469 metres to a junction with Public Footpath BA15/23 at grid reference ST 6602 6256 (Point C on the Order Plan).
- 2. Nothing in Article 1 of this order shall apply to any contractor necessarily proceeding to or from the said works.
- 3. This order shall come into operation on 7 July 2025 and will be operative for a period of six months. The Order may be cited as the Bath and North East Somerset Council (Public Footpaths BA8/26 & BA15/24, Wick Farm, Compton Dando) Temporary Traffic Regulation Order 2025.
