This document sets out Bath & North East Somerset Council's proposed approach to discharging its Duty of Cooperate. Duty to cooperate bodies were consulted on a draft of this document in January 2018. The document has been amended to take into account the comments received and to reflect the revised National Planning Policy Framework (NPPF).

1. Background

- 1.1 Bath & North East Somerset Council (B&NES) is preparing a new Local Plan. This will include a strategy to guide development and site allocations (including strategic development locations and smaller sites) to meet development requirements as well as district-wide Development Management policies for determining planning applications.
- 1.2 The Local Plan is being prepared within the context of and alongside the West of England Joint Spatial Plan (JSP), which will provide a new strategic plan for all four West of England Districts¹. Both plans cover the period 2016-2036.
- 1.3 The currently anticipated programme to adoption of the Local Plan is summarised below and may be subject to change dependent on the progress of the JSP Examination.

2. The Duty

- 2.1 Through Section 33A (1) of the Planning and Compulsory Purchase Act 2004 (as amended through Section 110 of the Localism Act 2011) Bath & North East Somerset Council has a duty to co-operate (DtC) with neighbouring authorities and other prescribed public bodies on strategic planning issues that cross administrative boundaries relevant to their areas in the preparation of a Local Plan. The duty:
 - relates to sustainable development or use of land that would have a significant impact on at least two local planning areas or on a planning matter that falls within the remit of a county council
 - requires that councils set out planning policies to address such issues

- requires that councils and public bodies 'engage constructively, actively and on an ongoing basis' to develop strategic policies'
- requires councils to consider joint approaches to plan making
- 2.2 The objective is to establish a robust and transparent process to enable cooperation with the relevant local authorities and organisations to be demonstrated. It will also enable cooperation to be documented and monitored in terms of the strategic issues to be addressed, the outcomes achieved and the frequency of engagement with the relevant authorities and other public bodies. Moreover, this should enable the Council to demonstrate that engagement has been:
 - constructive



- 2.3 As part of the consultation process and through the DtC the Council seeks to engage with neighbouring local authorities at an early stage to establish what the strategic cross-boundary issues may be in relation to the emerging B&NES Local Plan. The local authorities that border B&NES are:
 - Bristol City Council
- Mendip District Council
- South Gloucestershire Council

North Somerset Council

- Wiltshire CouncilSomerset County Council
- 2.4 The map below illustrates this relationship geographically.



- 2.5 The DtC also covers a number of public bodies in addition to neighbouring local authorities. These bodies are set out in Part 2 of the Town & Country Planning (Local Planning) (England) Regulations 2012. Those particularly relevant to Bath & North East Somerset are:
 - Environment Agency
 - Historic England
 - Natural England
 - Mayor of London (not relevant to B&NES)
 - Civil Aviation Authority
 - Homes and Communities Agency
 - Clinical Commissioning Groups
 - National Health Service Commissioning Board
 - Office of the Rail Regulator
 - Highways England
 - Integrated Transport Authorities
 - Highway Authorities
 - Marine Management Organization (not relevant to B&NES)
- 2.6 The revised National Planning Policy Framework (NPPF) (2018), paragraph 24 also expects local planning authorities to work collaboratively to identify the relevant strategic matters they need to address in their Plans. They are also expected to engage with local communities and other relevant bodies such as Local Enterprise Partnerships and Local Nature Partnerships when preparing plans. For B&NES these are the West of England Local Enterprise Partnership and the West of England Nature Partnership (WENP). The Council will also liaise with other strategic infrastructure bodies in neighbouring areas as appropriate should a mutual strategic cross-boundary matter arise. This would include adjoining Clinical Commissioning Groups and water authorities.
- 2.7 The NPPF also requires that in order to demonstrate effective and on-going joint working, strategic policy-making authorities should prepare and maintain one or more statements of common ground, documenting the cross-boundary matters being addressed and progress in cooperating to address these. These should be produced using the approach set out in national planning guidance, and be made publicly available throughout the plan-making process to provide transparency.
- 2.8 B&NES is also a constituent part of the West of England Combined Authority (WECA) along with Bristol City Council and South Gloucestershire Council. The WECA governance arrangements formalise the close working arrangements between the three Unitary Authorities.
- 2.9 In the West of England, the scope for a statement of common ground will need to be considered on matters not covered by WECA.

3. Strategic issues for Bath & North East Somerset

- 3.1 The Local Plan Commencement Document published in November 2016 for consultation² represented the start of the plan preparation process. It included an initial list of strategic issues affecting B&NES considered to have cross-boundary impacts:
 - Strategic relationship/implications of the amount and type of development planned for and allocated
 - Implications of strategic site allocations (where cross boundary impacts are possible)
 - Cumulative impact of non-strategic allocations e.g. at Bath or areas of B&NES close to the boundary with another authority such as the Somer Valley
 - Assessments and delivery of strategic infrastructure, in particular transport, where either cross boundary or close to authority boundary
 - Policy/site issues raised through HRA e.g. relating to bats
- 3.2 A number of issues were raised through consultation responses in relation to the DtC. These are summarised in the Appendix 2 of the Commencement Document Consultation Report (November 2017)³ together with an officer response. The points raised, as summarised below, have been reflected in this paper (see in particular, Table 4 on page 12):
 - May not be just site allocations and infrastructure that can have cross boundary implications (Wiltshire Council)
 - Potential role towns in Wiltshire and Mendip, could/should have on the provision of affordable housing (South Stoke Parish Council and Bath Preservation Trust)
 - Review of the Duty to Co-operate with neighbouring authorities, particularly Bristol (CPRE Avonside)

4. Strategic Priorities for Bath & North East Somerset

4.1 Drawing on evidence collated by the Council underpinning its corporate strategy (e.g. through the Joint Strategic Needs Assessment) and set out in the Sustainability Appraisal Scoping Report the key challenges facing B&NES have been identified. They have been summarised and categorised into seven main themes and are expressed as critical issues in the Issues & Options consultation document (Winter 2017).

Table 1 : Critical Issues

Changing local population & housing needs:

- Housing affordability crisis across B&NES and lack of social housing
- Significant increase projected in younger and older age groups
- Considerable recent & projected student population growth
- Increase in the number of second homes in parts of B&NES

Health

- Health & life expectancy inequalities across B&NES
- 60% of adults over-weight or obese
- Poor air quality in parts of B&NES leads to health problems

Climate change

- Climate change impacts already being felt both globally & locally
- Technological advances create opportunities for low or zero carbon development

Economy

- Below-average productivity levels & earnings in B&NES
- Retaining an adequate supply of employment land & premises in key strategic locations
- Inequality of employment opportunities

Environment

- High quality natural, built & historic environment requiring protection and enhancement
- Threat to environment & need for and maintenance of additional green infrastructure arising from development & other pressures

Transport & Infrastructure

- Severe traffic congestion in some parts of B&NES
- Poor accessibility to national/regional transport network
- Difficulties of providing infrastructure capacity to cope with increasing population

Financial changes

- Increased pressure on limited public sector resources to meet current & projected demands
- 4.2 The priorities moving forward are aimed at addressing these key challenges. Given that the Local Plan is able to influence and help shape spatial outcomes (those that result in or require the use of or changes to places, land and buildings) a set of spatial priorities have been identified. As with the key challenges these spatial priorities will often inter-relate e.g. prioritising greater walking or cycling helps to address climate change issues, as well as increasing physical activity thereby addressing health priorities.
- 4.3 The critical issues and priorities identified in the JSP have also been taken into account and reflected in the Local Plan spatial priorities. The JSP focusses on meeting housing needs across the sub-region in a sustainable way and delivering economic growth that is inclusive for all sections of the community. Alongside facilitating development the JSP aims to protect the area's high quality environmental assets, as well as maintaining

the overall function of the Bristol and Bath Green Belt partly by prioritising development on brownfield opportunities within the main urban areas.

5. Duty to Cooperate engagement

- 5.1 The Council proposes to work constructively with its Duty to Cooperate partners and other relevant bodies throughout the preparation of the Local Plan building on existing working relationships and arrangements already in place. Emphasis will be on seeking to achieve effective and deliverable policies in the Local Plan that provide land and infrastructure to support current and projected levels of development having sought to address strategic cross-boundary matters.
- 5.2 Cooperation and engagement is envisaged as being iterative and continuous throughout the plan-making process especially at key stages (see summary programme at paragraph 1.3 above). The Council intends to employ a range of positive and constructive methods appropriate and proportional to the matter(s) and those which will result in the most effective outcomes for the parties involved. Although not exhaustive the approaches listed below are considered effective mechanisms of engagement dependent on the nature of the issue and the strategic partners involved:
 - Meetings
 - Working groups
 - Workshops
 - Written exchanges
 - Statements of Common Ground
- Memoranda of Understanding
- Telephone conferences and Skype for Business and other methods which reduce the need to travel
- Other joint working mechanisms
- 5.3 Such partner arrangements will need to be fit for purpose and agreed between the relevant strategic partners to ensure the cooperation leads to positive outcomes for

the parties involved. In seeking to produce effective and deliverable policies on strategic cross boundary matters potential outcomes might reasonably include:

- aligning planning policies with those of neighbouring local planning authorities
- preparing mutually beneficial evidence base
- preparing management plans and strategies which address cross-boundary issues
- 5.4 Table 3 (page 9) provides a list of Duty to Cooperate bodies and general overview of what the Council considers to be potential key cross-boundary interests. Table 4 (page 11) sets out the potential strategic cross-boundary matters pertinent to each of the proposed spatial priorities and identifies those strategic partners the local planning authority considers should be involved through the DtC.
- 5.5 It is acknowledged that not every organisation with which the Council might need to involve in cross-boundary issues have necessarily been identified at this stage. However, through on-going co-operation the Council will seek to ensure their interests are properly considered in the preparation of the Local Plan and acknowledged in future iterations of this report. It is also recognised that during the preparation of the Local Plan new partnership relationships might emerge which will need to be taken into account.
- 5.6 The intention is therefore that this report will be updated as necessary to reflect any comments received on this proposed approach; in light of new evidence; other cross-boundary issues arising of relevance to DtC bodies and/or changes in Government policy regarding the Duty to Cooperate.
- 5.7 The DtC is a legal test and will be examined by the appointed planning inspector when the Local Plan is submitted. The Council will therefore need to provide robust evidence to demonstrate what efforts have been made to cooperate on crossboundary issues, with whom the Council has cooperated, the nature and timing of this cooperation and how it has influenced the preparation of the Local Plan.
- 5.8 It should be noted that the four WoE UAS have demonstrated their continued commitment to joint working most recently through the preparation of the West of England Joint Spatial Plan (JSP)⁴ and that the DtC will also be discharged through delivering the West of England Joint Spatial Plan (see also para 5.9 below). These joint working arrangements are also evidenced through the following:
 - Joint Waste Core Strategy
 - Joint Transport Study and Joint Local Transport Plan
 - Joint Affordable Housing Supplementary Planning Document
 - Joint Green Infrastructure Plan
 - The JSP Memorandum of Understanding

- The Mayoral Spatial Plan
- Joint Monitoring via the Joint Planning Data Group (JaPDoG)
- West of England Local Aggregates Assessment (LAA)
- 5.9 It should be noted, however, that the JSP and the Local Plan are two separate processes (one providing the strategic policy framework for the other) and whilst there is a relationship, the Duty to Cooperate undertaken for the JSP does not replace the Council's Duty to Cooperate in the preparation of its Local Plan. The JSP is currently at Examination. 6. Future reporting, monitoring and review

6.1 The Council must provide details of the activities that it has undertaken on the Duty to Cooperate in its Authority's Monitoring Report (AMR). This is a requirement under Regulation 34(6)) the Town and Country Planning (Local Planning) (England) Regulations 2012⁵. It is also envisaged that a Duty to Cooperate report would be prepared and/or updated at each stage of the consultation process. This will provide the opportunity to take account of comments received during the consultation and consider whether the arrangements for joint working are working effectively and enable refinements to be made where necessary.
