Statement of Common Ground between Bath & North East Somerset Council and Historic England

Introduction

Historic England made representations on the Draft Placemaking Plan during the seven week consultation period (16 December 2015 – 3 February 2016). The Council, as part of its consideration of representations made under Regulation 20 of the Town & Country Planning (Local Planning) (England) Regulations 2012, summarised the main issues arising from duly made representations from all respondents including those from Historic England. The Council provided responses to the main issues identified as documented in the Regulation 22(1) (c) Statement (CD/PMP/G13).

The Council has proposed a number of amendments to the Placemaking Plan in the Schedule of Limited Changes which have been submitted to the Inspector for consideration alongside the Placemaking Plan. This includes changes in response to concerns raised by Historic England.

Historic England has further responded to confirm which of the proposed changes address their concerns and those they still wish to resolve (CD/PMP/R1). In view of Historic England's status as a statutory consultee, in recognition of the importance of heritage issues to Bath & North East Somerset and in light of the fact that Historic England considers that these are matters of soundness, the Council has agreed to provide a response with the intention of resolving their outstanding concerns. The schedule below relates to Historic England's outstanding areas of concern and reflects the outcome of the informal discussions between the Council and Historic England.

These changes are included in the 'Schedule of Rolling Changes' (CD/PMP/E1) for consideration by the Inspector.

Deletions to existing text are shown as strike through and additional text is shown as underlined.
